## RESOLUTION

**WHEREAS:** the Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections I and II of the Pawnee Nation Constitution, and

**WHEREAS:** the Pawnee Business Council met in special session on January 14, 2015 at the Pawnee Nation Roam Chief Event Center, duly authorized, and with a quorum present, and

**WHEREAS:** the Pawnee Business Council has reviewed the applicants who filed for tribal membership with the Pawnee Nation pursuant to the membership provisions of the Pawnee Nation's Constitution, and

**WHEREAS:** the Pawnee Nation Enrollment Committee met on December 18, 2014 to review all applications submitted for enrollment and then submitted to the Nasharo Council forty-one (41) approved eligible applications for enrollment. At a Nasharo Council Special Meeting held on December 20, 2014, forty-one (41) applications for enrollment were approved by the Nasharo Council by Resolution #14-06 for submission to the Pawnee Business Council for final approval by Pawnee Business Council Resolution, and


## CERTIFICATION
