## RESOLUTION

- Whereas,** The Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the Pawnee Nation Constitution and By-Laws; and
- Whereas,** The Pawnee Business Council met in special session on November 4, 2015, at the Pawnee Nation Multi-Purpose Building, duly authorized, with a quorum present; and
- Whereas,** the Pawnee Nation is calling for a Special Election to fill the vacant position of President of the Pawnee Business Council (Article VI of Pawnee Nation Constitution); and
- Whereas,** the Pawnee Business Council enacts the Election Ordinance of the Pawnee Nation of Oklahoma under the authority delegated by Article IV, Section 4-1, of the Constitution of the Pawnee Nation of Oklahoma; and
- Whereas,** the conduct, activities, purpose and intent provided by the Election ordinance is to establish procedures for fair elections and to insure the secrecy and sanctity of the ballot, regulations and procedures contained in the Election Ordinance which will be administered by the Election Commission; and
- Whereas,** the Pawnee Business Council will appoint the special Election Commission (Section 4 and 13 (c) of the Election Ordinance); and
- Whereas,** Steven Bird is appointed to the Chairman position effective November 4, 2015 with a term ending May 31, 2016; and
- Whereas,** Margaret Twins is appointed to the Clerk position effective November 4, 2015 with a term ending May 31, 2016; and
- Whereas,** Delilah Moses is appointed to the Sergeant-at-Arms position effective November 4, 2015 with a term ending May 31, 2016; and




