RESOLUTION

- Whereas,** The Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the Pawnee Nation Constitution and By-Laws; and
- Whereas,** The Pawnee Business Council met in special session on August 26, 2020, at the Pawnee Nation Building 64 Conference Room, duly authorized, with a quorum present; and
- Whereas,** the Pawnee Business Council, as the supreme governing body of the Pawnee Nation, approved, endorsed and ratified the Pawnee General Revenue and Taxation Act, as amended on April 25, 2007; and
- Whereas,** the Pawnee Business Council recognizes the need to strengthen the Pawnee Tribal government by providing for current expenses of the Tribal government and to provide financing for expansion of Tribal governmental operations and services through tax revenue provided and generated by the General Revenue Taxation Ordinances; and
- Whereas,** the Pawnee Nation Tax Commission met in a regular scheduled session on February 20, 2020 with a quorum present, and submits the recommendation to amend the Pawnee General Revenue and Taxation Act; and
- Whereas,** the Pawnee Business Council finds it necessary to amend Chapter Ten (10), Section 1002 (A), regarding annual vehicle registration tax and the annual vehicle registration tax brackets; and

NOW, THEREFORE BE IT RESOLVED, the Pawnee Nation Business Council does hereby approve the amendment to Section 1002 (A) of Chapter Ten of the General Revenue and Taxation Act, as amended April 25, 2007, Resolution #07-20, to increase the table of tax rates by fifteen percent (15%) per tax bracket.


BE IT FURTHER RESOLVED, the Pawnee Nation Business Council does hereby approve the amendment to Section 1002 (A) of Chapter Ten of the General Revenue and Taxation Act, as amended April 25, 2007, Resolution #07-20, to increase the vehicle tax bracket cap from \$15,000 to \$80,000, and implement tax brackets in between.


CERTIFICATION


