RESOLUTION

WHEREAS, the Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections I and II of the Pawnee Nation Constitution, and

WHEREAS: the Pawnee Business Council met in a Special Meeting on January 14, 2015 at the Pawnee Nation Roam Chief Event Center, duly authorized, and with a quorum present, and

WHEREAS: according to the Constitution of the Pawnee Nation of Oklahoma, Article III - Membership of the Tribe, Section 3. (ii) A person shall not be eligible for membership, if enrolled as a member of another Indian Tribe; and

WHEREAS: The Pawnee Nation Enrollment Department received documentation from the Bureau of Indian Affairs, Pawnee Agency that **Mark Lloyd Bush** is dually enrolled with the Osage Nation; and

WHEREAS: The Pawnee Nation Enrollment Department notified Mark Lloyd Bush by certified mail on April 3, 2014 of being dually enrolled and he was given at least thirty days to relinquish from the Osage Nation; and

WHEREAS: The Pawnee Nation Enrollment Department received documentation from the Osage Nation December 16, 2014 that Mark Lloyd Bush is still currently an enrolled member of the Osage Nation and has not submitted a relinquishment to be removed from the Osage Nation; and

WHEREAS: the Nasharo Council held a meeting December 20, 2014 and dual enrolled tribal member, Mark Lloyd Bush, was reviewed by the Nasharo Council, Resolution #14-06 was approved for submission to the Pawnee Business Council to remove Mark Lloyd Bush from the Pawnee Nation Membership Roll by Pawnee Business Council Resolution, and


NOW, THEREFORE BE IT RESOLVED, the Pawnee Business Council does hereby remove Mark Lloyd Bush from the Pawnee Nation of Oklahoma Membership Roll.


CERTIFICATION
