## RESOLUTION

**A RESOLUTION APPROVING MEMBERSHIP INTO THE UNITED INDIAN NATIONS OF OKLAHOMA, KANSAS AND TEXAS (UINOKT) AND NAMING W. BRUCE PRATT AS DELEGATE AND DAWNA HARE AS THE ALTERNATE DELGATE.**

- Whereas,** The Pawnee Business Council is the supreme governing body of the Pawnee Nation and is authorized to conduct business on behalf of the Pawnee Nation in accordance with Article IV, Sections 1 and 2 of the Pawnee Nation Constitution and By-Laws; and
- Whereas,** The Pawnee Business Council met in special session on September 29, 2016, at the Pawnee Nation Multi-Purpose Building, duly authorized, with a quorum present; and
- Whereas,** the purpose of this organization is to adhere and enhance the preservation and continuity of the membership's rights, powers, laws and privileges as demonstrated by treaties and laws of the United States of America and provide for a unified effort in exerting tribal government authority through tribal regulatory laws and ordinances and constitutions; and
- Whereas,** the Pawnee Nation of Oklahoma meets all requirements for membership pursuant to Article III – Membership of the Constitution and bylaws of the United Indian Nations in Oklahoma, Kansas and Texas and does agree to pay membership fees totaling \$2,000; and
- Whereas,** the Pawnee Business Council and the Pawnee Nation are in support of the efforts being made in Indian Country; and
- Whereas,** this Resolution supersedes Resolution #15-42.


**NOW, THEREFORE BE IT RESOLVED** the Pawnee Business Council, being the supreme governing body, does hereby approve payment of \$2,000 to be paid to the United Indian Nations of Oklahoma, Kansas and Texas (UINOKT) for membership dues, and naming W. Bruce Pratt as Delegate and Dawna Hare as the Alternate Delegate.


## CERTIFICATION
